1. This R & W sheet was handed to Mr. Hall by Mr. Friedman recently.
2. All pages except the first of the proposed amendment to the subject application have been rewritten to incorporate several new claims in the form requested by you.
3. If the attached sheets numbered 2-5, incl., are substituted for the sheets 2 and 3 previously given you, your file of the proposed amendment will correspond to our file.
4. New claims 34 and 35 are method claims setting forth the steps accomplished by your system. These claims appear to be in the proper form for method claims, but may be rejected on the ground that they unpatentably distinguish from the prior art. New claims 36 and 37 are specific to the control commutator per se of Figure 2. New claim 38 is similar to claims 1-33 already in the case.
5. The proposed amendment has not yet been filed. It will be filed as soon as you approve the same. If no word is received by July 27, 1942, it will be necessary to file the amendment anyhow to save the case from abandonment.
