In accordance with the procedures outlined in a carrier sheet, 14 November 1947, from AS-80 to AS-85, subject "Packaging and Accounting for Reserve Cryptographic Devices," it is requested that two officers be made available to AS-85 for the packaging of the ASAM 2-1. Attention is invited to the provisions of paragraph 8 of the referenced carrier sheet which state:</p> <p style="margin-left: 40px;">"8. a. At least one of the two certifying officers will be from sources other than AS-82 or AS-85.</p> <p style="margin-left: 40px;">"b. One of the two certifying officers will be Regular Army."</p> <p>2. The officers will be required in AS-85 during the period 1300 to 1630 each working day. It is estimated that it will require approximately two weeks to complete the packaging of units now available.</p> <p>3. Attention is further invited to the fact that, at approximately the time the present equipment is packed, the normal output of the Branch will require two officers to be available fifty to seventy-five percent of the afternoons of each working day. As soon as the Department of the Navy starts to deliver the ASAM 18 units under the proposed contract, the services of two officers will be required every afternoon.</p> <div style="text-align: right; margin-top: 20px;">  K. <p>1. Captain Holcomb, AS-26, has advised Security Division that two officers, one Regular Army, will be made available to Security Division for the period of approximately two weeks required for packaging ASAM 2-1 equipments. These officers will meet the present requirements.</p> <p>2. However, in view of the extended packaging program outlined in paragraph 3 above, Security Division requests that an officer be permanently assigned to AS-85. This officer should be a 9610 and will be made custodian of cryptomaterial, AS-85. Further, the services of a second officer, Regular Army, will be required each afternoon on a long-term basis.</p> <p>3. It is, therefore, requested that the Deputy Chief, Army Security Agency make the necessary arrangements to assign to Security Division an officer, MOS-9610, and to make available a Regular Army officer for each afternoon on a long-term basis.</p>			<p><i>H.
