1 I am of the opinion that a requirement exists for an advisory body to the Joint Chiefs of Staff on matters involving communications intelligence and communications security. The present lack of an advisory body is a result of the provisions of National Security Council Intelligence Directive No. 9, Revised, 29 December 1952,* that relieve the Armed Forces Security Agency Council of its responsibility in the communications intelligence field without establishing a similar body to operate within the military establishment.

2. Accordingly, I recommend that the provisions of J.C.S. 2010, and J.C.S. 202/72, which establish and provide a charter



TERMS OF REFERENCE

FOR

JOINT SECURITY COMMITTEE

PURPOSE

1. The Joint Security Committee (JSC) is established as the advisory body to the Joint Chiefs of Staff on such matters pertaining to communications intelligence (COMINT) and communications security (COMSEC) as may be referred to the Joint Chiefs of Staff.

COMPOSITION

2. The JSC shall consist of.

<u>a</u>. The Army, Navy and Air Force Members of the United States Communications Intelligence Board (USCIB), one of whom shall be appointed Chairman, JSC, for a one year term by the Joint Chiefs of Staff The chairmanship shall be rotated among the Scruces.

<u>b</u>. Not to exceed two additional members from tach of the Services to be selected by the Services.

 \underline{c} An alternate for each Service JSC Member who shall have plenary powers to act in the Member's absence.

<u>d</u>. A representative from the Joint Staff appointed by the Director, Joint Staff, to attend JSC meetings as an observer in order to maintain close liaison between interested agencies.

RESPONSIBILITIES AND FUNCTIONS

3 Acting under the authority of the Joint Chiefs of Staff and with their approval, when required, the JSC will:

<u>a</u> Make recommendations concerning joint operating plans and doctrine for the implementation of COMINT requirements within the Armed Services.

<u>b</u>. Determine joint policies, operating plans and doctrine for communication security activities, and imitative cover and deception

<u>c</u>. Recommend to the Joint Chiefs of Staff, the facilities (except communications facilities), personnel and fiscal and logistic support to be provided by the Services to NSA, such recommendations to be based on requirements as determined by the Director, NSA.

d Coordinate joint cryptologic military requirements.

e Consider such communication sccurity and communication intelligence matters as may be referred to the Joint Chiefs of Staff by the Director, NSA.

<u>f</u> Coordinate all communication security and communication intellibence matters which affect communication-electronics with the Joint Communications-Electronics Committee.

PROCEDURE

4. The JSC will:

<u>a</u>. Establish its own methods of procedure within the established policies of the Joint Chiefs of Staff.

<u>b</u> Strive for unanimity in its advisory actions to the Joint Chiefs of Staff. When unanimity cannot be reached, substantive matters, as determined by the Chairman, shall be referred to the Joint Chiefs of Staff for resolution

AUTHORITY

5. The JSC is authorized to.

<u>a</u>. Request information and assistance which may be required in connection with its functions from the Joint Chiefs, Joint Committees under the Joint Chiefs of Staff, and the elements of the military services that are concerned with COMINT and/or COMSEC.

b. Establish such subcommittees as may be required to assist JSC in the performance of its functions.
