- 1. Approval of Final Minutes of the 26th and 27th Meetings. Corrections to tentative minutes of 26th meeting distributed as USCIB 5.3/84. Comments on tentative minutes of 27th meeting now being received and will be distributed in advance of the meeting.
- COMINT Relations with In USCIB 29.19/19 the Director. 2. NSA reported on his discussions with the Director and presented for approval a summary of his views on future courses of action in COMINT relations with These views were circulated to USCIBEC for vote sheet action, and were approved by all members except those representing Army and Air Force PL 86-36/50 USC 3605 (USCIB 29.19/19), who requested consideration of the proposal at this meeting. USCIB 29.19/20 reports views on the subject relations, and USCIB 29.19/21 contains information on the status of base rights negotiations.
 - 3. COMINT Relations with On 16 February 1955, USCIBEC held a special meeting to consider the reply (USCIB 29.17/16) to our query (enclosure with USCIB 29.17/15) regarding the intended use by of U.S. equipment requested by them. Based on the Committee's decision (USCIB 29.17/20) an ad hoc committee consisting of the Executive Secretary, the NSA and Air Force members drafted a proposed message to LSIB (enclosure with 29.17/18) which was approved by USCIB (USCIB 29.17/21) and transmitted. LSIB's reply is contained in USCIB 29.17/23, which has been distributed for use as a basis for discussion at this meeting.
 - Counter-Clandestine COMINT Planning. USCIB 9.6/3 constitutes a 4. progress report on this subject ending with certain conclusions and a recommendation which, if approved, will provide a framework within which the Intelligence Committee may expedite development of a program in this field.
 - Transmission of COMINT Unencrypted Over Third Party Countries. 5. The Director. NSA has submitted a status report on the development of a Secure Film Carrier (USCIB 13.6/26) which will serve as a basis for discussion of the overall problem at this meeting.
